

MENTAL CAPACITY ACT AND THE COURT OF PROTECTION SEMINAR

13 April 2011 at City Campus East, Northumbria University

This seminar will provide an opportunity to consider and reflect on the development of and the current role of the Court of Protection (CoP) and the Mental Capacity Act (MCA) 2005 in practice. We are delighted to be able to pull on the considerable experience within the School of Law, and in particular our visiting academics, to share their thoughts and experiences on some of the topical and challenging issues (a) raised by the MCA and (b) considered by the CoP since its re-figuration.

One of the areas which causes considerable debate and raises many, seemingly as yet unanswered, issues is that of deprivation of liberty. We will be considering the Deprivation of Liberty safeguards, focusing on the concept of liberty and what this means.

We will consider the role of the CoP in the context of decision-making about personal welfare matters and property and affairs matters. We will look at the interesting question of those decisions which fall outside the MCA (and the Mental Health Act) and the issues which these raise.

We will provide an overview of recent developments and their impact. There will be ample opportunity to put questions and make comments to our expert panel. The seminar is intended to be of considerable interest and practical assistance to lawyers, social workers, doctors, academics and other professionals whose work brings them into contact with CoP or/and the MCA.
