We are pleased to welcome as our Keynote Speaker Mr Justice (Sir Jonathan) Baker of the High Court Family Division who has presided over a number of highly influential cases in the Court of Protection and will reflect on his judgment in the first case of withdrawal relating to a patient diagnosed as 'minimally conscious': W v M and Ors [2011] EWHC 2443 (Fam). The *Journal of Medical Ethics* has published a number of articles discussing this judgment, which was also widely covered in the media.
